The TCG stands for the total of the qualified University graduated engineers in Greece (architects, civil engineers, surveying engineers, etc) and consists of more than 80.000 people.

In the framework of this specific activity, the TCG participates and monitors not only the activity held by FIG but also by all Committees consisting together with the Hellenic Association of the Rural & Surveying Engineers the two members which represent Greece at FIG. The TCG supported from the very beginning the idea of this Meeting 2000 - Com3, in Athens, with the subject "Spatial Information Management" and for the same reasons it actively participates.

The topic of this year meeting "Experiences and Visions for the 21st Century" is very interesting and by combining the parallel and rapid changes we live through the last decade on digital technology and the "Spatial Information Management", it is anticipated that the perspectives of the relevant applications for the next century will be very important not only to the surveying engineers but also to all scientists and generally all people.

However, all the top level studies, applications and programs for infrastructure programs and district development, urban development and regional development as well as countries' development are still based on these specific methodologies.
