
WG 1.1 International Ethical Standards

WG 1.1 Ethics has been led by Gary Strong from the UK. Gary's links to the RICS, and the RICS leadership in the International Ethics Standards Coalition (IESC) has enabled the Commission to be involved with this international initiative.

Unfortunately, procedural issues have delayed the alignment of the FIG Ethics statement with the IESC publication, but it is expected that this will occur at the next general Assembly in Hanoi in 2019. Irrespective, Gary will be continuing his work in raising awareness of ethical issues in FIG through the Commission Work Plan for 2019-22.
